

**MINUTES FOR REGULAR COMMISSION MEETING HELD MARCH 5, 2007

UTAH**

Road Department Items

Consideration Of Tax Adjustments – Treasurer

Treasure Neslon stated that Property #00-0001-4377 was sold and during closing the county's computer system showed no back taxes due. She stated it must have been a computer glitch because there is actually back taxes of one thousand, one hundred twenty dollars and seventy-six cents (\$1,120.76) owing. She stated that it should be neither the seller's or the buyer's responsibility because during closing the county stated that nothing was owed. *Commissioner Harrison motioned to waive the back taxes due to the fact that the county's computer system failed to show the back taxes during closing. Commissioner Wood seconded the motion. All commissioners voted aye and the motion passed.*

Treasurer Nelson presented a tax deferral application for Property #00-0008-9445. She stated that the homeowner intends to have the back taxes paid by the end of the year. *Commissioner Harrison motioned to approve the tax adjustment. Commissioner Wood seconded the motion.
